



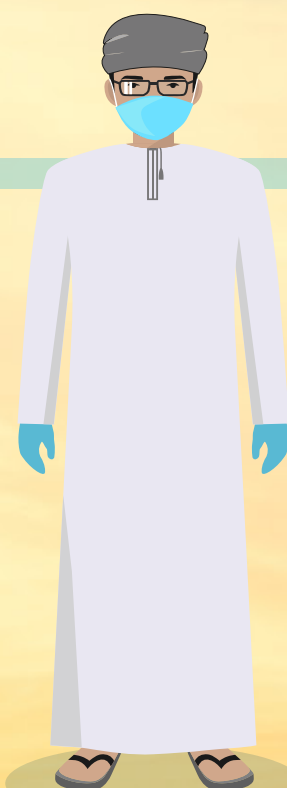

# Corona Virus Travel Guide (Covid-19)

# Before travelling – for departing travellers.

1

Passengers shall comply with the required documents, and go through the examinations and procedures of the destination country.

2

Omani citizens shall have health insurance covering Covid-19 valid in the country they are travelling to.

3

Checking in and finalizing all travel procedures online is highly recommended whenever possible.

4

Passengers must arrive at the airport at least 3-4 hours before their departure time.

5

No passenger suffering from Covid-19 or its symptoms, that were indicated by the Ministry of Health, may be allowed to enter the airport.

6

All passengers are to wear face masks in the proper manner in the airport.

7

Only travellers are allowed to enter the airport departure station. Non-travellers shall not be allowed entry except people with reduced mobility.

8

Travellers may carry only one handbag with them and an additional bag from the duty-free market to avoid crowds at the security points and in the airplane.

9

Citizens and foreigners are allowed to travel from Oman without permit.



# While travelling – for travellers in the airport and on the airplane.

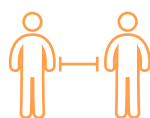

All passengers shall have their temperature measured upon entering the building, and they will only be granted access if their temperature is below **38 c**.



Those quarantined are required to report any Covid-19 symptoms when noticed and declare their infection if confirmed.



Social distancing shall be practised by all passengers at all times, and they shall adhere to the regulations and instructions, and ground labels that are used to maintain order at the airport.



Hands must be washed with soap and cleaned with hand sanitizers after any documents exchange. Sanitizers are available in all airport facilities.



All passengers are to remove their face masks to confirm their identity whenever required by policemen at passport counters, security points, or anywhere in the airport.



Whenever possible, it is highly recommended to pay electronically and use self-service counters at the airport.



All passengers are to avoid being too close together during boarding and while being inside the plane. Social distancing is obligatory at all stage of travel and all instructions to maintain physical distancing shall be followed at all times.



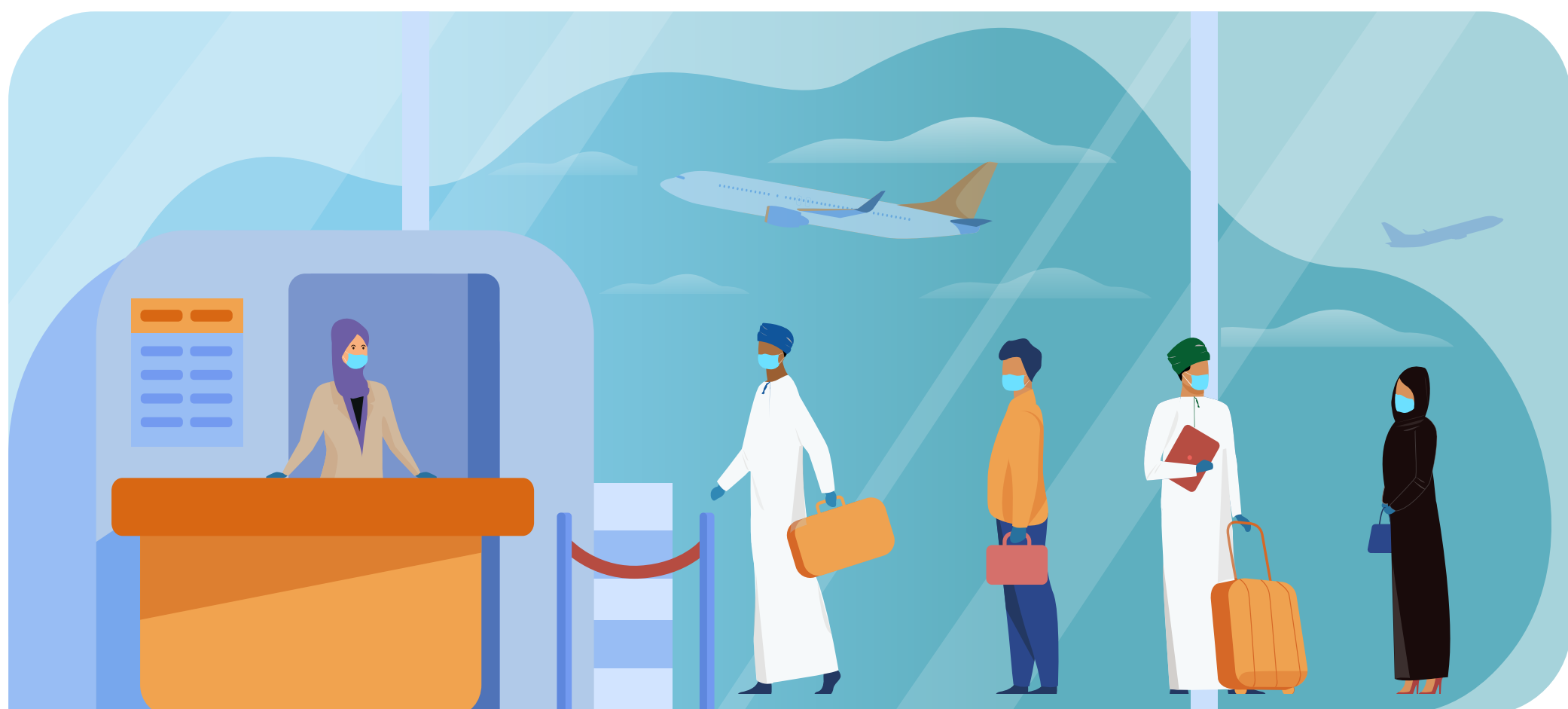
All travellers shall keep their masks on for the whole duration of the flight.



All passengers are to remain seated in the plane during the flight. Only move when it is necessary or when asked to exit the plane upon arrival.



All used face masks and gloves are to be disposed in the designated waste bins.





# Travellers coming into the Sultanate.

Only Omani citizens and residents with valid visas are allowed to enter the Sultanate without the need for prior approval.

3

All Arrivals shall download (Tarassud+) application in their mobile phone before arriving to Oman.

5

All arrivals shall have their temperature measured and those with covid-19 symptoms shall be directed to the designated clinics for examination.

6

All arrivals to Oman are subject Covid-19 (PCR) test and pay the cost of services of RO 25 and the following:

- Before departure to the Sultanate of Oman, passengers must complete pre-registration for the PCR test via <https://covid-19.emushrif.om/traveler/travel>
- All passengers arriving to the Sultanate of Oman are subject to covid-19 (PCR) test on arrival, and wear the electronic bracelet, quarantine for 7 days and (PCR) test on the eighth day.
- Aircraft crew, and children from the age of 15 years and less are exempted from Covid-19 (PCR) test.

All visitors are required to have health insurance that covers the costs of treatment Covid-19 for a period of one month, except for citizens of the Gulf Cooperation countries and holders of free treatment cards .

4

The period of pre-travel negative COVID-19 PCR test has been amended for long international flights (not less than 8 hours including transit) to be conducted within 96 hours prior to the scheduled time of arrival in Oman. The requirement for negative COVID-19 PCR test for shorter flights is to be conducted within 72 hours.

- Institutional quarantine applies to all non-Omani arrivals into the Sultanate, including families with children under the age of 18. All medical and medical assistance categories, and working in governmental, private and international institutions, and their family members are exempted from the mandatory institutional quarantine upon arrival to the Oman, and shall adhere to home quarantine and wear the electronic tracking bracelet.
- Omani citizens arriving in Oman are exempted from the mandatory institutional quarantine, but should undergo a isolation, other procedures applicable to all arrivals in the Sultanate.
- All arrivals to the Sultanate must book accommodation in hotels and institutional isolation on the (Sahala) except for Omani citizens and groups excluded from the institutional quarantine.

Aircraft crew are exempted quarantine subject to the precautionary measures issued by the Ministry of Health.

Non-travellers may not enter the airport without a proper permit.

Until further notice for arrivals from the following countries, and arrivals from any other country if they have passed through any of aforementioned countries during the previous **14** days preceding their request to enter the Sultanate of Oman. This excluded Omani citizens, diplomats, healthcare workers and their families who will be subject to the approved procedures upon arriving in the Sultanate of Oman, the countries are:

- Islamic Republic of Iran
- The Federal Republic of Nigeria
- The Islamic Republic of Pakistan
- The Federal Republic of Brazil
- The Federal Republic of Tanzania
- The Socialist Republic of Vietnam
- The United Kingdom
- The Kingdom of Thailand
- The Republic of India
- The Republic of Philippines
- Malaysia
- The Republic of Sierra Leone
- The Republic of Indonesia
- The Republic of Argentina
- The Republic of Iraq
- The Republic of Colombia
- The Republic of Bangladesh
- The Republic of Tunisia
- The Republic of Sudan
- The State of Libya
- The Federal Democratic Republic of Ethiopia
