These hours of flight instruction under supervision shall include the assessment of the applicant's competence as described in FCL.920.			
b	For MCCI, the instructor competencies are assessed continuously during the training course.

## 8. MCCI Privileges and conditions.

- (a) The privileges of an MCCI are to carry out flight instruction during:
  - (1) The practical part of MCC courses when not combined with type rating training; and
  - (2) In the case of MCCI(A), the basic phase of the MPL integrated training course, provided he/she holds or has held an FI(A) or an IRI(A) certificate.

#### 9. MCCI Restricted privileges.

- (a) The privileges of the holder of an MCCI certificate shall be restricted to the FNPT II/III MCC, FTD 2/3 or FFS in which the MCCI training course was taken.
- (b) The privileges may be extended to other FSTDs representing further types of aircraft when the holder has completed the practical training of the MCCI course on that type of FNPT II/III MCC, FTD 2/3 or FFS.
