a	Examiner shall hold an equivalent license, rating or certificate to the ones for which they are authorized to conduct skill tests, proficiency checks or assessments of competence and the privilege to instruct for them.			
b	Examiner shall be qualified to act as PIC in the aircraft during a skill test, proficiency check or assessment of competence if conducted on the aircraft.			
c	Examiner shall demonstrate, that they have not been subject to any sanctions, including the suspension, limitation or revocation of any of their licenses, ratings or certificates issued in accordance with this Regulation for non-compliance with Civil Aviation Law and Regulation during the last 3 years.			
d	Examiner shall have completed an examiner an examiner refresher course in accordance with CAR FCL.1025 which is provided by the CAA or which is provided by an ATO/operator and approved by the CAA in the period of 12 months immediately preceding the application for the renewal.			
e	Examiner shall demonstrate continued compliance with requirements laid down in CAR FCL.1010 "relevant knowledge related to the privileges of an examiner" - examiner assessment of competence report.			
f	Examiner shall demonstrate their competence with requirements laid down in CAR FCL.1020 to an inspector from the CAA or a senior examiner specifically authorized to do so by the CAA through the conduct of a skill test, proficiency check or assessment of competence in the examiner role for which privileges are sought, including briefing, conduct of the skill test, proficiency check or assessment of competence, and assessment of the person to whom the test, check or assessment is given, debriefing and recording documentation - examiner assessment of competence report..			
g	Examiner shall demonstrate continued compliance with the requirements laid down in CAR FCL.1030 - examiner assessment of competence report.
