Instruction on the applicable requirements in this Regulation and the applicable air operati requirements, the conduct of skill tests, proficiency checks and assessments of competence, and their documenta and reporting, a briefing on the CAA administrative procedures, requirements for protection of personal data, liabi accident insurance and fees and an instruction on how to get access to these national procedures and requirements</li> <li>Practical training. The conduct of at least 2 skill tests, proficiency checks or assessments of competences for licenses, ratings or certificates for which the applicant seeks the privilege to conduct tests and checks including brief conduct of the skill test and proficiency check, assessment of the applicant to whom the test or check is given, debrie and recording or documentation under the supervision of an examiner of the appropriate category on the applicable by</li> </ul>
