7. SAFETY, SECURITY AND FACILITATION CHARGES

7.1 Passenger category rate per departing international passenger is 0.850 OMR.

7.2 Exemptions:

- a) Infants under the age of 2 years;
- b) Aircraft crew on duty travel in uniform with a valid Airline ID card;
- c) Transit passengers.

8.2 Aerodrome Charges:

~~7.1~~ a) Unless an alternative arrangement has been made, all charges ~~for the use of the~~ are payable by the pilot of the aircraft at the time of using the aerodrome or by pre-payment prior take-off. In addition to the currency specified, payment will be accepted in Pounds Sterling or American Dollars cash. Travelers cheques may be exchanged at the bank on arrivals.

~~7.2~~ b) In the case of approved regular users who have been granted credit facilities, on demand at the end of each calendar month in respect of charges accruing, during that month.

~~7.3~~ c) Until the settlement of the due charges, the aerodrome operator is entitled to prevent take-off, with regard to the safety of the flight.

~~7.4~~ d) In case of claims against the legal basis of the charges, payment and recovery, the Laws of Oman is to be applied.

1.1 En-route Air Navigation Services Charge – Method of Calculation

Calculation formula:

The charge per flight will be calculated in accordance with the following formula:

$$\text{Charge} = 30.24 \text{ [USD]} * \sqrt{\frac{\text{MTOW[tn]}}{50}} * \frac{\text{GCD[km]}}{100}$$

1.1.1 Great Circle Distance flown

a) In respect of an aircraft transiting the Muscat Flight Information Region (FIR), the great circle distance flown is the shortest distance in kilometers between the entry and exit points of the Muscat FIR.

b) In respect of an aircraft entering the Muscat FIR and landing at an airport within the Muscat FIR, the great circle distance flown is the shortest distance in kilometers between the FIR entry point and the aerodrome, minus 20 km due to the Terminal Air Navigation charge.

c) In respect of an aircraft departing an aerodrome within the Muscat FIR and exiting the Muscat FIR, the great circle distance flown is the shortest distance in kilometers between the aerodrome and the FIR exit point, minus 20 km due to the Terminal Air Navigation charge.

d) In respect of an aircraft both departing from and arriving at an aerodrome within the Muscat FIR, the great circle distance flown is the shortest distance in kilometers between the aerodromes, minus 40 km due to the Terminal Air Navigation charge.

Note: The calculation of the (great circle distance flown/100) shall be carried to 2 decimal places.

1.1.2 MTOW: Maximum Take Off Weight as specified by the manufacturer and found on the aircraft's certificate of airworthiness.

1.1.3 Discount of 50% to domestic and international flights (landing or take-off) at an aerodrome within the Omani airspace.

1.1.4 Minimum charge: In all cases the minimum air navigation charge of 100.00 USD shall apply.

1.1.5 Route A791 Flat Rate Charge: For aircraft utilizing route A791 in either direction between LALDO and IMLOT there is a flat rate charge of 325.00 USD.

1.2 Terminal Navigation Charges – Method of Calculation

Calculation formula:

The terminal charge per flight will be calculated in accordance with the following formula:

$$\text{charge} = 36.60 \text{ [USD]} * \left(\frac{\text{MTOW[tn]}}{50} \right)^{0.7}$$

Note: Only charged for Departing flights.

1.2.1 MTOW: Maximum Take Off Weight as specified by the manufacturer and found on the aircraft's certificate of airworthiness.

1.2.2 Discount of 50% to domestic flights departing from an aerodrome within the Omani airspace.

1.2.3 Minimum charge the fees shall not be less than (25) twenty five USD.

1.2.4 Terminal formula only applies for the first 20 km of a Departing flight, after which the Enroute formula will be applied.
