a	Examiner shall hold an equivalent license, rating or certificate to the ones for which they are authorized to conduct skill tests, proficiency checks or assessments of competence and the privilege to instruct for them.		
b	* Examiner shall be qualified to act as PIC in the aircraft during a skill test, proficiency check or assessment of competence if conducted on the aircraft.		
c	Examiner shall have not been subject to any sanctions, including the suspension, limitation or revocation of any of their licenses, ratings or certificates issued in accordance with this Regulation for non-compliance with Civil Aviation Law and Regulation during the last 3 years.		
d	Examiner shall have completed an examiner an examiner refresher course in accordance with CAR FCL.1025 which is provided by the CAA or which is provided by an ATO/operator and approved by the CAA in the period of 12 months immediately preceding the expiry date of the certificate.		
e	Examiner shall have conducted at least six skill tests, proficiency checks, assessments of competence, or EBT evaluation phases during an EBT module before the expiry date of the examiner certificate.		
f	Examiner shall have conducted one of the skill tests, proficiency checks, assessments of competence or EBT evaluation phases conducted in the period of 12 months immediately preceding the expiry date of the examiner certificate and shall have been assessed by an CAA inspector or by a senior examiner specifically authorized to do so by the CAA - examiner assessment of competence report.		
g	* If applicants for the revalidation hold privileges for more than one category of examiner, all examiner privileges may be revalidated if applicants comply with the requirements for one of the categories of examiner certificates held, in agreement with the CAA.
