Note

- All Classes of Medical Certificates included in a Professional Aircrew license shall be valid for privileges in accordance with CAA Medical regulation.
- Attach this Medical Certificate to the License.
- Medical Certificates may be renewed up to 45 days before expiry date.
- If renewal is delayed, written explanation is to be provided, citing the reasons for delay along with a declaration of not having flown within CAA airspace during this period.
- License holders shall not exercise the privileges of their license and related ratings or certificates at any time when they:
 - Are aware of any decrease in their medical fitness which might render them unable to safely exercise those privileges.
 - Take or use any prescribed or non-prescribed medication which is likely to interfere with the safe exercise of the privileges of the applicable license.
 - Receive any medical, surgical or other treatment that is likely to interfere with flight safety.
 - Any incapacitating injury or illness that has resulted in grounding of 20 consecutive days or more.
- In addition, license holders shall, without undue delay, seek aero-medical advice when they:
 - Have undergone a surgical operation or invasive procedure.
 - Have commenced the regular use of any medication.
 - Have suffered any significant personal injury involving incapacity to function as a member of the flight crew.
 - Have been suffering from any significant illness involving incapacity to function as a member of the flight crew.
 - Are pregnant.
 - Have been admitted to hospital or medical clinic.
 - First require correcting lenses.

Limitation Code and Description

TML	Restriction of the period of validity of the medical certificate
VDL	Correction for defective distant vision and carry a spare set of spectacles
VNL	Correction for defective near vision and carry a spare set of Spectacles
CVL	Requirement for visual correction for Cabin Crew and to carry a spare set of spectacles.
CCL	Correction by means of contact lenses only
VCL	Valid by day only
HAL	Valid only when hearing aids are worn
APL	Valid only with approved prosthesis
OML	Valid only as or with qualified co-pilot
OCL	Valid only as co-pilot
SSL	Special restriction as specified
OAL	Restricted to demonstrated aircraft type
AHL	Valid only with approved hand controls
SIC	Specific regular medical examination(s) - contact licensing authority
RXO	Specialist ophthalmological examinations
VML	Correction for defective distant, intermediate and near vision
OSL	Operational safety pilot
MCL	Restriction to operate only in multi-cabin crew operations
OAL	Restriction to specified aircraft type(s)
OOL	Restriction to a specified type of operation
CVL	Requirement for visual correction for Cabin Crew and to carry
OPL	A spare set of spectacles
VXL	Valid only without passengers (PPL only)
VXN	Correction for defective distant vision depending on the working environment
